

## FAQ

### **1. Who are eligible to apply for re-examination of answer script(s)?**

Eligibility criteria of re-examination are governed by CSR-54/09 dated 24.11.2009. A candidate appearing at any examination as a whole can apply for re-examination of theoretical papers only excluding MIL papers, ENGC and ENVS.

Provisions in respect of Part I/II Examinations are:

- (i) A General Course candidate may seek re-examination of not more than two papers/portion of papers provided he/she secures at least 35% of the total marks in the remaining papers/portion of papers of all subjects taken together.
- (ii) An Honours/Major Course candidate may seek re-examination of (a) not more than one Honours/Major paper/portion of paper provided he/she secures at least 35% of the total marks in remaining papers/portion of papers of the Honours/Major subject or (b) not more than one Honours/Major paper/portion of paper and one General paper/portion of paper provided he/she secures at least 35% of the total marks in the remaining papers/portion of papers of the Honours/Major and all General subjects taken together or (c) not more than two General papers/portion of papers provided he/she secures at least 35% of the total marks in the remaining General papers/portion of papers of all General subjects taken together.

Provisions in respect of Part III Examinations are:

- (i) A General Course candidate may seek re-examination of not more than two general papers /portion of papers provided he/she secures at least 35% of the total marks in the remaining papers/portion of papers of all General subjects taken together.
- (ii) An Honours/Major Course candidate may seek re-examination of not more than two Honours/Major papers/portion of papers provided he/she secures at least 35% of the total marks in remaining papers/portion of papers of the Honours/Major subject.

### **2. Who can apply for FSI (For Self Inspection) of answer script(s)?**

Any student who has appeared in the examination can apply for FSI of theoretical papers. There is no restriction on number of answer scripts for FSI.

**3. Where to submit forms and fees ?**

Candidates are required to submit their forms and fees to their respective colleges within stipulated time.

**4. After submitting the application of re-examination can I change the paper later?**

No, you cannot. Once the application for re-examination is submitted for some paper(s)/portion of paper(s), you cannot change it.

**5. After submitting the application of re-examination can I apply for re-examination for additional paper subsequently?**

Yes you can do that as long as the eligibility criteria as mentioned above are fulfilled.

**6. My result is incomplete, can I apply for re-examination/ FSI ?**

After completion of your result, contact University through your college for Re-examination / FSI .

**7. Marks in MIL, ENGC and ENVS are not satisfactory, what to do?**

At present there is no provision for re-examination / FSI of those subjects.

**8. Not satisfied in some practical paper marks, what to do?**

At present there is no provision for re-examination / FSI of practical papers.
